The impact of trauma shapes all aspects of the relationships between clients and service-providers, and between supervisors and supervisees in the helping professions. By implementing a trauma-informed approach, supervisors can reduce the risk secondary (or vicarious) trauma among their staff, prevent burnout and turnover, and ultimately create an environment that improves outcomes for clients.

This 3-hour web-based training will provide supervisors with a general understanding of trauma informed care principles and practices in direct service and supervision.

Specific training about essential components of effective supervision and infusing these trauma-informed principles into supervision experiences with direct reports will be provided.

The training will be lecture based with small group breakout sessions for more in depth discussion of topics and practice with case study examples.

#### **Objectives**

At the conclusion of this training, participants will be able to:

1. Identify basic elements of trauma-informed care practices.
2. Identify essential elements of effective supervisory relationships and practices.
3. Integrate trauma informed-care principles with new understandings of supervision practices in practical and applicable ways. And,
4. Practice applying the principles of trauma through case studies and discussion with other supervisors.
